**A REFERENDUM ON RIVES TOWNSHIP ORDINANCE NO. 2015-4,  
THE RIVES TOWNSHIP ZONING ORDINANCE,  
ADOPTED BY THE RIVES TOWNSHIP BOARD OCTOBER 13, 2015**

**INTRODUCTION** - The Rives Township Board of Trustees adopted Ordinance No. 2015-4, the Rives Township Zoning Ordinance, at a regular Township Board meeting on October 13, 2015. A referendum petition was filed by certain Township residents in accordance with the Michigan Zoning Enabling Act, P.A. 110 of 2006, MCL §125.3101 et. seq. (“Michigan Zoning Act” herein), requesting that the Zoning Ordinance adopted by the Township on October 13, 2015 be approved by Rives Township voters prior to becoming effective. This proposition is for the purpose of seeking voter approval of Ordinance No. 2015-4, the Rives Township Zoning Ordinance adopted on October 13, 2015, in accordance with Section 402 of the Michigan Zoning Act, being MCL §125.3402.

**PURPOSE AND EFFECT OF ORDINANCE NO. 2015-4** – Ordinance No. 2015-4 is a re-adoption of the Rives Township Zoning Ordinance currently in effect in the Township. Ordinance No. 2015-4 makes amendments and revisions to the Rives Township Zoning Ordinance primarily for the purpose of bringing the Zoning Ordinance into compliance with requirements in the Michigan Zoning Act. The purpose and intent of Rives Township Ordinance No. 2015-4 is to replace the currently effective Zoning Ordinance which provides for the regulation of land development in the Township by the establishment of zoning districts where agricultural, residential, commercial, and industrial uses are segregated and permitted to meet the needs of the Township’s citizens for food, fiber, energy, and other natural resources, to provide for places of residence, recreation, industry, trade, services, and other uses of land, and to otherwise regulate the use of land and structures to ensure that use of land is situated in appropriate locations and relationships, to limit the inappropriate overcrowding of land and congestion of population, transportation systems, and other public facilities, to facilitate adequate and efficient provision for transportation systems, sewage disposal, water, energy, education, recreation, and other public service requirements, and to promote public health, safety and welfare.

**Approval of Ordinance No. 2015-4:**

- Will update and revise the existing Rives Township Zoning Ordinance consistent with requirements in the Michigan Zoning Act;
- Will redefine certain terms and definitions in the Zoning Ordinance to facilitate better administration of zoning regulations and to clarify application of zoning regulations to existing and future uses.
- Will repeal and replace the current Rives Township Zoning Ordinance with an updated and revised zoning ordinance;
- Will not change the existing zoning map or any existing zoning district boundaries currently established in the Rives Township Zoning Ordinance; and
- Will not change current enforcement and penalties for violation of zoning regulations.

**Non-Approval of Ordinance No. 2015-4:**

- Will mean that the Rives Township Zoning Ordinance currently in effect will remain effective with parts of the Zoning Ordinance not in compliance with requirements in the Michigan Zoning Act; and
- Will not eliminate current zoning district regulations under the existing Rives Township Zoning Ordinance.
